Explanation of Changes: There were multiple items that contributed to this amendment. A new drinking fountain at the city park of \$15,235, fully funded by a grant. The fire department purchased an \$8,000 ram, fully funded by grant money. Boone County provided \$15,000 in ARPA funds for city projects that included a new door, stove and globes at the park. An individual made a large donation to Ogden Fun Days, the Veterans Monument and a memorial plaque that was not budgeted for. There were \$30,0000 in storm sewer emergency repairs. Some past fix up grant funds were paid in this budget year. Police car was purchased with available funds but not budgeted for.
